I arrived home at 9:30 p.m. on July 21 from Cairo, Egypt where I conducted the 2<sup>nd</sup> ICHPER-SD Middle East Leadership Conference and executed the "*Agreement*" as a binding contract mandated by the ICHPER-SD Operating Code with Dr. Farouk Abdel-Wahab, President, and Dr. Mosaad Ewies, Secretary General of the 53<sup>rd</sup> World Congress and Exposition Organizing Committee (WCEOC'2011) in Cairo, Egypt.

The Conference was staged in the auditorium of the Egyptian Olympic Committee. Over 100 registered HPERSD professionals from the Middle East region participated. As far as the Agreement is concerned; there were no significant addendums to the ICHPER-SD Operating Code, and Dr. Adel Elnashar, our counter parts and myself all signed the contract.

Via the Leadership Conference, we were able to recruit the following *4 new Life members* and collected life membership fees in accordance with each of their preferred payment schedules:
